## **Plant & Equipment**

We do not possess or operate heavy plant and equipment; the vast majority of our work is undertaken using hand tools only. Power tools such as 110 Volt SDS drills are used occasionally. If high level access equipment (e.g. scaffold tower or mobile elevating working platform) is required, this is hired in from firms registered with the CPA, and will only be operated by suitably qualified personnel; details will be provided at the time the work is booked in.

## **Hazardous Activities**

Other than occasional work at height, we do not undertake any hazardous work such as use of naked flames, welding/burning or excavation.

## **Site Safety**

We do not routinely work on construction sites.

Our technicians typically work alone or sometimes in pairs and are usually required to visit several sites each day; on that basis we do not often undertake site safety meetings or carry out on-site toolbox talks. Training is delivered either online or at our Headquarters building.

## **Investigation & Enforcement**

We have had no investigation or enforcement action taken against us in relation to any Health & Safety issues in the last 5 years.
